- Except with the previous approval of the Central Government, no member shall be appointed to any office under the company which is remunerated by salary, fees, or in any other manner not excented by sub-clause [3].
- 5. Nothing in this clause shall prevent the payment by the company in good faith of reasonable remuneration to any of its officers or servents (not beings members) or to any other person (not being a member) in return for any services actually rendered to the company.)

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by, its members or others, any regulation or restriction which, if an object of the company, would make it a Trade Union.
